I am writing to formally request exclusion from the settlement class in Caccuri v. Sony Interactive Entertainment LLC. I wish to opt out of this class action entirely, waive all rights to compensation from this settlement fund, and preserve my right to pursue independent legal action against Sony Interactive Entertainment LLC.

Please note that in May 2026, I successfully opted out of the Sony Interactive Entertainment LLC Dispute Resolution / Arbitration Agreement within the mandated 30-day window following the April 2026 Terms of Service update. Consequently, I retain full rights to pursue formal litigation in a court of law.

Statement of Claim and Reason for Exclusion:

I am opting out due to immediate financial and digital injury caused by ongoing PlayStation Network defects. On June 16, 2026, a major PSN server failure erased my digital game library. To attempt to restore access to my purchased games (including Just Cause 4), I was forced to reactivate my PlayStation Plus subscription at 11:40 PM on Tuesday, June 16, 2026. Despite paying out-of-pocket, Sony's system failed to restore my licensed products. Furthermore, your records verify additional purchases and software expansions on my account which remain blocked or permanently deleted ("content vaulted") by your subsidiary, Bungie. I intend to pursue full cash refunds for breach of contract and deceptive trade practices independently.

Please process this exclusion request immediately.

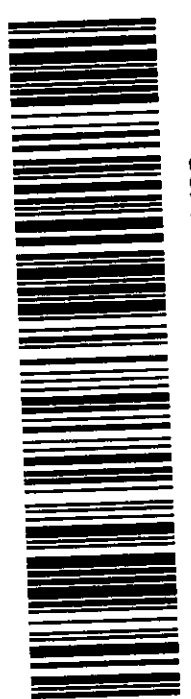
