## **PLAN OF ALLOCATION**

### **I. Amount Payable to An Eligible Claimant**

1. If a person or entity is not a Settlement Class member or has timely and validly requested exclusion from the Settlement Class, then that person or entity shall not be entitled to any distribution from the Settlement. If a person or entity is a member of the Settlement Class and has not timely and validly requested exclusion from the Settlement Class (each such person or entity, an “Eligible Claimant”), then that Eligible Claimant’s eligibility to participate in this Plan of Allocation and the method of calculation for, or amount of payment, the Eligible Claimant shall receive (if any) is described below. The Settlement Amount shall be distributed to Eligible Claimants as follows.

### **II. Definitions**

1. “Qualifying Purchase” shall mean the purchase of any video game from the PlayStation Store, from the period between April 1, 2019 to December 31, 2023, for which a game specific voucher (“GSV”) was available at retail prior to April 1, 2019, for which a total of at least 200 GSV redemptions were made prior to April 1, 2019, and for which the post-discount price increased by fifty cents from: (a) the period between January 1, 2017 and March 31, 2019; as compared to (b) the period between April 1, 2019 and December 31, 2023.

2. “Net Settlement Amount” shall mean the Settlement Amount less Court-approved attorneys’ fees, reimbursement of costs and expenses, service awards, and fees and costs associated with issuing notice and settlement administration.

3. “Notice” shall mean the legal notice authorized by the Court in *Cendejas et al v. Sony Interactive Entertainment LLC*, Lead Case No. 3:21-CV-003361-AMO which is pending in the United States District Court for the Northern District of California, San Francisco Division.

### **III. General Exclusions**

The following individuals or entities are excluded from the distribution of the Settlement Amount:

- (a) Defendant and its counsel, officers, directors, management, employees, parents, subsidiaries, and affiliates; and
- (b) All judges assigned to this case and members of their immediate families.

#### **IV. Distribution Among Eligible Claimants**

1. The Net Settlement Amount shall be distributed to Eligible Claimants on a *pro rata* basis not to exceed 100% of recoverable damages.

2. To determine each Eligible Claimant's *pro rata* share of the Net Settlement Amount, the Settlement Administrator shall multiply the Net Settlement Amount by a fraction for which: (a) the numerator is the applicable number of Qualifying Purchases for that Eligible Claimant; and (b) the denominator is the sum total of all applicable Qualifying Purchases by all Eligible Claimants.

3. After determining the *pro rata* share of each Eligible Claimant, that amount will be distributed in the form of PlayStation Network ("PSN") account credits, which can be redeemed for any content available for purchase in the PlayStation Store, and will be deposited directly in Eligible Claimants' PSN accounts. Eligible Class members with inactive PSN accounts will be able to contact the case call in 877 number and provide a current address in order to receive monies they may be entitled to under the settlement.

4. Persons or entities who have opted out of the Settlement Class shall not receive any of the Net Settlement Amount.

#### **V. Amendments to the Plan of Allocation**
